

## **PUBLIC NOTICE**

### **APPLICATIONS FOR THE POSITION OF RECTOR OF ISCTE – INSTITUTO UNIVERSITÁRIO DE LISBOA**

1. Iscte-Instituto Universitário de Lisboa, hereinafter referred to as ISCTE, hereby publicly announces the opening of the application procedure for the position of Rector.
2. The Rector, the highest governing body and of external representation of ISCTE, is elected by the General Council, for a four-year term of office, performing duties on an exclusive basis, pursuant to the provisions in Article 23 of the Statutes.
3. Professors and researchers of ISCTE or other university education or research institutions, national or foreign, that are not covered by any ineligibility or incompatibility laid down in the law and in the Statutes of ISCTE, may apply to the position of Rector.
4. The Rector should fulfil the following requirements:
  - a) Be a personality of recognised merit with relevant professional experience for the duties to be performed;
  - b) Possess a strategic vision suited to the pursuit of the mission and goals of ISCTE, under the terms of its Statutes;
  - c) Communicate appropriately in the Portuguese language.
5. The applications are submitted by the actual applicants, addressed to the Chairperson of the Election Committee, in the Portuguese language, between 8 November 2021 and 4 January 2022.

7. It is mandatory for the applications to be accompanied by the following elements:
  - a) Curriculum of the applicant;
  - b) Solemn declaration that the applicant is not in any of the situations of ineligibility laid down in the Law or in the Statutes of Iscte-Instituto Universitário de Lisboa;
  - c) Action programme that the applicant proposes to follow drafted in the Portuguese language;
  - d) Indication of the e-mail address to which notifications of the Election Committee's decisions can be sent.
